MSA Inspection Recommendations

The User must inspect the harness and check the fall arrest force indicator before each use. This inspection log can be used as a guide for pre-use User inspections. All harnesses must be formally inspected by a competent person prior to first use. MSA requires that all harnesses be inspected by a competent person other than the user at intervals of no more than one year per applicable standard or as specified by a formal fall protection program. Record formal inspections in the Inspection Log. Indelibly mark the inspection grid attached to the harness. Do not use a harness with a formal inspection date older than one (1) year unless under provision of formal inspection program. For additional inspection details, reference the V-FIT Arc Flash instructional manual.
